# TERMS OF CONTRACT

## 1. APPLICATION FOR PARTICIPATION

All applications for participation shall be made on the prescribed application form and shall be submitted to the Organiser or their authorised Representatives. The Organiser shall reserve the right to accept or refuse any application without disclosing to the Exhibitor any reasons whatever thereof.

## 2. ALLOCATION OF EXHIBITION SPACE

The Organiser shall allocate the space in accordance with the nature of exhibits or in any manner they may deem fit. The Organiser shall reserve the right to change the space allocated to the Exhibitor at any time prior to the commencement of the erection of the Exhibitor's booth should exceptional circumstances demand and to alter the Exhibition facilities and to undertake other structural alterations as they may deem fit. Such changes shall be at the discretion of the Organiser and the Exhibitor shall have no claim for compensation as a result of such changes.

## 3. CONSTRUCTION AND DECORATION OF STAND

Exhibitors will be allowed to decorate their unit as per appropriate schedule in the Exhibitor's Manual. Any damages caused by the Exhibitors or his contractors to other Exhibitors or common property shall be the responsibility of the Exhibitor. Exhibitors must complete their construction and decoration by the date and time stipulated by the Organiser.

## 4. MOVEMENT OF EXHIBITS

- Exhibitors shall bear the expenses and be responsible for the transport of exhibits to the Exhibition Venue.
- Exhibitors shall make their own arrangements for storage and warehousing of the exhibits.
- Exhibitors shall remove all exhibits from the Exhibition hall within the period stipulated by the Organiser and shall not indemnify the Organiser against any loss by reason of the delay or damage to the exhibits.

## 5. FAILURE OF SERVICES

The Organiser shall not be liable for any loss sustained by the Exhibitor directly or indirectly attributable to the cancellation, suspension or reduction of duration of the scheduled Exhibition from the period advertised or specified due to:-

- Force Majeure
- Acts of War, Military Activity, Municipal Statutory or Civil Authority requisition.
- Fire, flood, typhoon, excessively inclement of weather, earthquake or a combination of the same.
- Damage caused by an aerial object or aircraft.
- Strikes or lockouts by workmen.
- Any other deemed beyond the control of the Organiser and its authorised personnel and contractors.

## 6. TERMS OF PAYMENT

- 50% of the charges payable by the Exhibitor under the Contract Form to be paid upon signing of the Contract Form.
- The balance shall be paid not later than **30 days** prior to the opening date of the exhibition.

## 7. BREACH OF CONTRACT AND WITHDRAWAL BY EXHIBITOR

Without prejudice to the rights and remedies of the Organiser in respect of any breach of the contract on the part of the Exhibitor. The Organiser may at their discretion allow the Exhibitor to withdraw from the Exhibition subject to the following conditions:-

- The Exhibitor must give written notice to the Organiser that he desires to withdraw and if the Organiser allow such withdrawal they will notify the Exhibitor of their decision in writing.
- Any payment to the Organiser will not be refunded.
- Should the Exhibitor fail to observe or comply with any of the terms and conditions contained herein or if the Exhibitor shall fail to pay any of the unit cost at the time, the Organiser may thereupon by written notice given to Exhibitors rescind the contract.
- Upon the Organiser exercising their right to rescind the contract under sub-clause (c) of this clause, they may but are not obliged to re-let or otherwise deal with the exhibition space contracted by the Exhibitor in default on such conditions as the Organiser shall deem fit. In the event the Organisers having elected but not able to relet the said exhibition space the Exhibitor in default shall be liable to pay the entire unit costs to the Organiser as liquidated damages for the loss of rental.

## 8. SECURITY

The organiser shall take all security precautions in the interest of the Exhibitors and visitors. However, the Organiser shall not be held responsible for any loss or theft of exhibits at the Exhibition hall during the build-up, show days, and dismantling periods. The organiser shall also not be held responsible for any loss or damage to exhibits or any article belonging to the exhibitors.

## 9. FIRE REGULATIONS

All materials in the stand and exhibition construction must be fire-proofed in accordance with local regulations.

## 10. INSURANCE, LIABILITY AND RISKS

All Exhibitors shall insure indemnify and hold the Organiser and the venue owners harmless in respect of all cost, claims, demands and expenses to which they be subjected as a result of loss or injury arising to any persons howsoever caused while the said person are upon or examining or passing the Exhibition stands during the tenancy of the Exhibition. The liability or risks of the employees, agents or exhibits shall be the responsibilities of the Exhibitors.

## 11. SUPPLEMENTARY CLAUSE

- Whenever necessary, the Organiser shall have the right to issue Supplementary regulations in addition to those in the terms of contract to ensure the smooth management of the Exhibition. Any additional written regulations and/or instructions shall form part of these Terms of Contract and they shall be binding on the Exhibitors.
- The failure to object to any breach of any clause herein by the Organiser shall not constitute agreement to modification of this agreement or a waiver of any subsequent breach of such clause.
